



**THE JCS HOME / SCHOOL HEALTH AGREEMENT AND RISK WAIVER
SEPTEMBER 2021**

JCS requests that in preparation for the upcoming return to school, families read the conditions for returning to school after the holiday in January. It is important that we all strive to maintain a low-risk environment and JCS looks to the families for their ongoing support in this. **Please answer the following questions.**

Risk Waiver

As a member of the JCS family community, we understand our commitment to help reduce the risk of the spread of infection and to maintain a low-risk environment. We will inform the school immediately if a family member is taken ill. We will inform the school if any family member travels in or out of Jogjakarta. We understand that if conditions cannot be met, it may result in our child being asked to study online during a quarantining period.

We accept our part in maintaining social responsibility and in keeping our children, staff and family members safe.

We have read the Safety Guidelines shared with families and will abide by them.

We have read and understood the Risk Waiver below and accept its content.

JCS acknowledges that there is no such thing as absolute safety and whilst we believe the risk is manageable, we cannot state that there is no risk.

Our staff will use their professionalism to create classroom environments which, to the best of their ability and within the limitations that exist, promote maximum safety as outlined in our guidelines. We will work closely with our students to ensure they follow the guidelines.

JCS will do its best to prepare for a safe environment. In the interest of JCS community, we ask parents to accept their part in this process and to follow safety guidelines not only in school, but in the family's daily activities. As a family who is part of the larger JCS community, it is essential we limit our social and physical interaction to trusted groups in order to reduce the risk.

The School may be required to raise or lower the response level at any time as directed by the appropriate authorities.

We understand that the school has the right to ask families to keep children at home and return to online learning if the above conditions are not met.
